'Building Back Better'

When the new bridge at Pooley Bridge is completed later this year it will permanently reconnect the local community, for the first time since the town's old bridge was washed away by Storm Desmond in 2015. Cumbria County Council, working with an extensive project team, oversaw the installation of the £5m single span stainless steel bridge, which was lifted into place on 12th May. The original bridge, built in 1764, was one of more than 700 bridges in Cumbria to be damaged by the 2015 storm, which was said to be a 1-in-700-year event.

Located in an ecologically sensitive place with multiple conservation designations, we are proud to have provided ecological & environmental support, from project concept through to final completion. This complex project called upon a wide range of PBA's in-house services, including baseline surveys, environmental permitting, protected species licensing, environmental management, construction monitoring and mitigation. The new single span bridge will better allow future storm flows to pass.

At Pooley, we have helped build the bridge 'back better'. Here at PBA we are also working to build our business 'back better'. With funding support from Leeds City Region Enterprise Partnership, our new AV suite will be a valued legacy of the pandemic. 

Leaving the EU - legal update

The UK exited the EU on 31 January with the transition period ending on 31 December 2020. In leaving the EU, the UK government has committed to maintaining environmental standards, and to continue to uphold international obligations. This commitment has also been mirrored by the devolved administrations. Hence, all European protected sites and species retain the same level of protection. The environmental assessment regimes that inform planning decisions (SEA/EIA/HRA) continue to apply post EU exit. All permits and licenses issued by UK regulatory bodies continue to apply. Also, the legal framework for enforcing environmental regulations through regulatory bodies and the courts remains unaffected.

This is also a good time to be aware of domestic environmental legislation that underpins most enforcement by regulators. For example, under the Wildlife and Countryside Act 1981 (as amended), a person commits an offence if he intentionally or recklessly disturbs bats while occupying a structure or place that is used for shelter or protection, or obstructs access to any such place. Similarly, the Salmon & Freshwater Fisheries Act 1975 makes it an offence to knowingly permit the flow of poisonous matter and polluting effluents into river courses, or to create obstructions to the passage of fish.
